#### **General Terms & Conditions**

- 1. The contract shall be for the supply, installation and commissioning of the mentioned items to the NCRMI office. The bidder shall quote for items in the format of quotation attached. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- The tender addressed to the Director, NCRMI in a sealed cover shall be accepted in the NCRMI office at Kudappanakkunnu up to 2 pm. latest by 14.09.2015.
- 3. The tender should be in the prescribed form which can be obtained from the officer mentioned in the tender notification on payment of the price noted therein. The cost of tender forms once paid will not be refunded. Tenders which are not in the prescribed form are liable to be rejected.
- 4. Intending tenderers should send their tenders so as to reach the officer mentioned in the tender notification, on due date and time noted therein. No tender received after the specified date and time will be accepted on any account. The rates will be considered firm for acceptance till the date mentioned therein. Tenders not stipulating period of firmness and tenders with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.
- 5. All duties, taxes and other levies payable by the bidder shall be included in the total price However, the tax and duties leviable should be quoted separately.
- 6. The firm /dealer should submit the technical pamphlets of the units for which quoted.

### **Duties and Taxes:**
